MEMORANDUM OF UNDERSTANDING

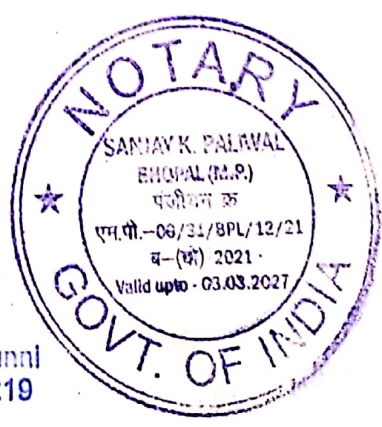

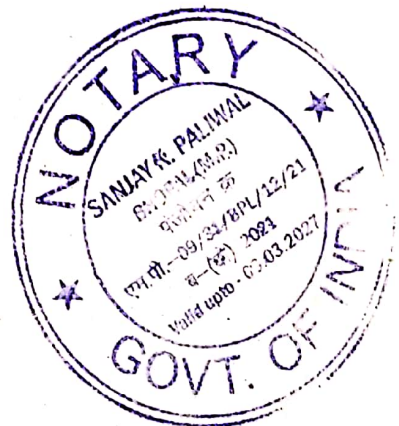
Govt. College, Sunni Shimla HP. - Will providing not only under-graduate programs like BA, BSc., B Com and BCA but also post-graduate programs in Hindi, Political Science, English, Commerce, Economics and PGDCA.. The campus is under CCTV surveillance, and had WiFi for internet connectivity. The classrooms are ICT enabled with Smart Panels.

WHEREAS the Parties desire to memorialize certain terms and conditions of their anticipated endeavor;
NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

1. **Purpose and Scope.** Shubh Enterprises. has signed an agreement with HP KVN to deliver the EEE program at **Govt. College, Sunni Shimla HP.** to 60 final year graduating students and would like to seek support from the **Govt. College, Sunni Shimla HP** to
 - 1.1. Appointing a Nodal Officer who would be the SPOC for all EEE related project and will provide assistance to the Shubh Enterprises team for smooth delivery of the project.
 - 1.2. Providing 1 (one) classroom and 1 Lab for training of the said candidates. The classroom to have the facility of a white screen and projector or Smart Panel. The room should have the requisite furniture and the capacity to accommodate at-least 30 candidates at a time.
 - 1.3. Maintenance and cleanliness of the classroom and Lab will be the responsibility of the **Govt. College, Sunni Shimla HP.** Classroom utilization, providing separate Wash Rooms for Male & Female students.
 - 1.4. Providing First AID Kit for any untoward incident.
2. **Objectives.** The Parties agrees as follows:
 - 2.1. The Parties shall work together in a cooperative and coordinated effort so as to fulfill the deliverables of the EEE Project.
 - 2.2. It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.
 - 2.3. This MOU is not intended to create any rights, benefits, and/or trust responsibilities by or between the Parties.
3. **Non-Disclosure.** The parties hereby agree that during the term of the agreement, the parties shall not use, commercialize or disclose Confidential Information to any person or entity. Upon termination, or at any time upon the request of the Disclosing Party, the Receiving Party shall return to the Disclosing Party all Confidential Information, including all notes, data, reference materials, sketches, drawings, memorandums, documentation and records, which in any way incorporate Confidential Information.

This section remains in full force and effect even after termination of the Agreement by its natural termination or the early termination by either party.

7. **Notices**

Any notices or other communications required or permitted under this agreement shall be in writing and shall be deemed to have been duly given and delivered when delivered in person, two (2) days after being mailed postage prepaid by certified or registered mail with return receipt requested, or when delivered by overnight delivery service or by electronic mail to the recipient at the following address, or to such other address or electronic mail as to which the other party subsequently shall have been notified in writing by such recipient.
